## ZARELLI SPACE AUTHENTICATION, LLC TERMS & CONDITIONS

By signing the front side of this form, customer acknowledges that they have read the Zarelli Space Authentication, LLC terms and conditions (the "agreement") set forth below and agrees to abide by this agreement, and further agrees that Zarelli Space Authentication is entitled to rely upon and benefit from this agreement.

- 1. Zarelli Space Authentication will endeavor to certify submissions within a reasonable time frame. However, Zarelli Space Authentication will have no liability whatsoever to the customer for damages (including incidental or consequential damages) allegedly due to Zarelli Space Authentication's failure to certify any submission within any time frame.
- 2. Fees paid to Zarelli Space Authentication are non-refundable once the autographed item begins the authentication process.
- 3. Certification and authentication involves an individual judgment that is subjective and requires the exercise of professional opinion, which can change from time to time. Therefore, Zarelli Space Authentication makes no warranty or representation and shall have no liability whatsoever for the opinion rendered by Zarelli Space Authentication to any submission.
- 4. Zarelli Space Authentication will exercise reasonable care in handling submissions for authentication. However, if Zarelli Space Authentication determines the customer's submission was lost or damaged while in Zarelli Space Authentication's possession, customer will be compensated based upon the fair market value of the submission as determined by Zarelli Space Authentication standard procedures, which may include filing a claim with our insurance carrier. The declared value you stated on the front of this form is for estimating the postal insurance coverage only, and the fair market value of the submission may be less than your declared value. In no event shall the total liability exceed the declared value of the item.
- 5.
